#### **POSITION OVERVIEW**

The Youth Leadership & Strategy Coordinator is central to this vision, guiding and coaching a team of Youth Ambassadors, with lived experience in the child welfare and/or juvenile justice systems. In this role, you'll provide mentorship, professional development, and opportunities for Ambassadors to drive improvements within their agencies and across New York City. We are seeking a passionate, highly skilled professional who believes in the power of youth voice, thrives in collaborative environments, and is ready to help shape a bold generation of leaders.

#### **KEY RESPONSIBILITIES**

### **Youth Ambassador Supervision & Coaching**

- Provide individualized coaching, guidance, and professional development to Youth Ambassadors.
- Conduct regular 1:1 check-ins to set goals, track progress and provide feedback.
- Foster a safe, empowering, and inclusive environment that centers youth voice and lived experience.
- Collaborate with Ambassadors to co-create individual leadership development plans and track impact over time.

## **Strategic Planning & Systems Change**

- Support Ambassadors in identifying systemic challenges and co-creating solutions that influence agency practice and citywide policy.
- Ensure youth recommendations are translated into action by serving as a bridge between Ambassadors and organizational leadership.
- Serve as a liaison between youth and leadership, ensuring Ambassadors' insights and feedback inform programmatic and policy decisions.

# **Agency & Community Engagement**

- Support Ambassadors in engaging peers and staff within their agencies to co-develop service improvements.
- Guide Ambassadors in navigating relationships with adult stakeholders and advocating effectively.
- Coordinate with agency partners to ensure Youth Ambassadors are supported, informed, and integrated into their agency's continuous improvement efforts.

### **Advocacy & Public Engagement**

- Support youth participation in rallies, public forums, press events, and legislative meetings.
- Prepare and coach Ambassadors to confidently represent their experiences and ideas in public forums, media and legislative settings.

### **Program Administration & Communication**

- Recruit and onboard Ambassadors annually in collaboration with agency partners.
- Track attendance, participation, and progress across all program components.
- Maintain strong documentation and contribute to program evaluation and reporting.
- Collaborate with staff to highlight and share Ambassador accomplishments.

- Lived experience in the child welfare and/or justice system.
- 3+ years of experience in youth development, community organizing, policy advocacy, or related fields.

- Experience designing and guiding youth-led strategic planning, campaigns, or community engagement efforts.
- Deep commitment to racial and social justice, youth empowerment, and equity.
- Ability to work flexible hours, including some evenings and weekends.
- Comfort navigating bureaucratic systems and partnering with agency stakeholders.
- Knowledge of NYC Foster Care and Juvenile Justice systems is preferred.
- A professional coaching certification by an accredited organization is preferred.
